1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on March 18, 2024 at 6:59 p.m. by President Stewart. President Stewart opened the meeting requesting a moment of reflective silence. The Pledge of Allegiance was led by Boy Scout Groups from different communities.

5. REMARKS AND REPORTS OF CITY OFFICIALS:

Mayor Brubaker:

Mayor Brubaker shared an update that twenty-five-year Waste Water Pollution Control employee, Tom Ortiz will be retiring at the end of March. A celebration will be held from noon until 2:00 p.m. at the plant, all are welcome to attend. Mayor Brubaker expressed his appreciation for Mr. Ortiz's years of service to the city of Elyria. March 18th Mayor Brubaker swore into the Elyria Fire Department the first in the history of Elyria Fire, a third-generation firefighter. The newly sworn in firefighter's father and grandfather were both firefighters' retirees from the Elyria fire department. In addition, Mayor Brubaker shared Purvie Smallwood had accepted a position to replace Rick Boone as the Public Works Coordinator in the Sanitation Department.

Safety Service Director:

SSD Pyanowski reminded everyone that on April 8th, the eclipse will take place from 3:00pm to 4:00pm. Trash pick up will run as scheduled. All city parks will be open during normal scheduled hours. No programming is scheduled. Overnight parking is prohibited at the parks. Additional traffic is expected through town as well. The expectation of visitors in Lorain County over the weekend is 100,000 to 500,000 people.

Finance Director:

Finance Director Pileski provided an update that the Independent Auditors were onsite with the city about a month ago for two days. The audit is ongoing, however most of the work is conducted off-site. All information is submitted via email and electronic drop-box. The audit will be ongoing through the months of June and July.

Council member Lipian inquired about non-partisan affiliated vacancies. Law Director Deery shared that the election would require the board of elections to review how the party voted. Council member Siwierka inquired about ward boundaries. Law Director Deery stated new ward boundaries will go into effect 2025.

Minutes Approved

EPD:

Chief Pelko shared information regarding the Elyria Police Department and Citizens remembered Sergeant Kerstetter, who was killed in the line of duty fourteen years ago. Chief Pelko provided his current staff totals: 81 officers, two in police academy training, two in field training program, four officers on family medical leave, and two officers on light duty. Seventy-one officers are available on the road. The department is looking to rehire an officer that was previously with the department once his background is cleared. Council member Oswald inquired about an update regarding the FBI Training Facility. Chief Pelko responded that meetings have been held with the city engineering department as well as the FBI, and he believes a referral has been submitted to move forward. Trees are being cleared away on the property and progress is being made. Council member Siwierka asked was their interest in police from the job fair and if any lateral benefits apply? Chief Pelko responded yes to lateral benefits are offered and yes, the job fair was beneficial to the police department as well. Candidates were screened for police and dispatch positions.

EFD: No report

Council member Oswald asked if this was the time of year to remind residents to change batteries in fire detectors. Chief Pronesti shared either fall back or spring forward are both good reminders of the campaign.

CD DIR. Scott: No Report

Engineer Schneider:

Engineer Schneider provided updates on all of the big projects in progress. Dilworth remains closed. East Broad will remain closed as of April 1st for restoration from Prospect towards Abbe Rd. East Broad Street with remain closed with the exception of open access to local property owners and businesses, due to excavating and undercutting work. April 15th, Cleveland Street process will start up again. Council member Lipian requested a review of his submitted streets prior to the utilities committee meeting. President Stewart inquired if there is more stabilization on the East Broad project with the amount of excavation that has taken place. He expressed concern with gas line placement and the timing of installation. Council member Siwierka inquired about a railroad update on East Bridge Street. Engineer Schneider contacted the engineer and was informed the project is very early on. The intent is to replace the bridges at East Bridge Street and improve the concrete walls and maintain the center pier. Council member Siwierka expressed concern regarding the sidewalk straps and if the city would have the ability to provide input on the project. Council member Schneider inquired if the lanes from South Abbe

to Route 57 are due to be painted. Engineer Schneider promised to follow up with all inquiries. Council member Mitchell asked when the street rankings would be completed. Engineer Schneider explained he was a bit behind schedule, however has some of the rankings, not all are processed. He explained he would like to travel the roads himself for assessment. Council member Mitchell expressed that the discussion of streets would be on-hold at the upcoming utilities committee meeting until rankings are completed and the process could be completed all at once. Council member Oswald inquired about the timing of the railroad inspections. Engineer Schneider responded he could confirm the timing of the railroad inspections. Council member Lipian stated that he and Council member Siwierka were looking at a Ward split of their streets regarding resurfacing.
