1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on August 5, 2024 at 7:03p.m. by President Stewart. President Stewart opened the meeting requesting a moment of reflective silence. The Pledge of Allegiance was led by Council member Davis.

5. REMARKS AND REPORTS OF CITY OFFICIALS:

Mayor Brubaker:

Mayor Brubaker provided an update regarding an EPA grant for a Chloride Reduction Program. The program is designed to reduce the amount of salt placed on the roadways. During the first round of grant approvals, the City of Elyria was not awarded. However, the week of July 29th, the administration received notification from McCaulley & Company that the city was awarded the grant in the second round of grant awards. The amount anticipated will be \$61,000. The matter had been previously passed by council through Issue 6. The equipment is scheduled for delivery after September 1, 2024. The purchase is reimbursable. If the decision is made to move forward with a central maintenance complex, the equipment will be housed there. Mayor Brubaker, thanked SSD Strohsack for his assistance with McCaulley & Company through the grant process.

Law Director Deery:

Law Director Deery provided an update to the newspaper article regarding the Law Director's filing of a nuisance action against the former Holiday Inn and former Days Inn. LD Deery explained that service may take some time, however service by publication is allowable. She expressed her appreciation to all city departments that were involved, police, fire and building. As well as Lorain County Pubic Health for their records, reports and citations. LD Deery informed council of the medical marijuana dispensaries that are currently operating in the City of

Elyria, who have applied for dual licensure. The dispensaries have been notified by the state cannabis control division that they need to apply under the new law. The law department has received confirmation that the dispensaries have received the green light for operations from the state. Each location, Sugar Lane, Nirvana and the Murray Ridge processor all plan to begin sells on Tuesday August 6, 2024. LD Deery stated the awareness of the city of Elyria has been made known to all locations. The dispensaries beliefs are that the state law permits them to go forward with sales.

Council member Schneider inquired where we might be in the zoning process? LD Deery responded she has a draft ordinance that requires some updates, however they will need to go before Planning Commission and a public hearing is required. It is safe to say that the beginning of October would be the soonest.

Council member Siwierka asked for clarification of the following, "the dispensaries are going to open, they would be violation of our building or zoning codes, they have interpreted our code as superseded by the state as allowing?" She asked for clarification of "where does it go from that point?" LD Deery explained the operator's interpretation is that if an entity already had its medical marijuana licensure, and they are looking to operate as dual use, adding on the adult use, they are already operating in the community and cleared by the state for dual operations, that the local level can not prevent the operations. LD Deery stated she believes there are constitutional and legal issues with that process of thought. Any challenges would require going to court. Council member Mitchell stated she understands fully that the dispensaries were approved for medical marijuana sales, met the zoning requirements for medical. She inquired about what is the difference in the zoning for medical and the zoning for adult use? LD Deery responded adult use zoning does not exist, we do not have requirements for parking. She explained the increase in foot traffic for adult use as opposed to medical. Council member Mitchell asked for further clarification on the difference, consider the building did not change in appearance, the licensing did not change. LD Deery stated the question would be best suited for the building department. Council member Tollett stated that at the beginning of medical marijuana discussions, there was a building on Cleveland Street, that was approved however did not open. He inquired would they qualify to open a retail facility? LD Deery responded it would depend on if the license were active. Mayor Brubaker was able to provide a full update regarding the Cleveland Street building as he recently toured the building. He explained the license was pulled, the building has recently been completely gutted, is not usable and the company is no longer in the area. Council member Oswald inquired to BO Farkas is this a case of changing the conditional use. Is it a matter of changing the use from medical marijuana to medical and recreational marijuana. BO Farkas explained the change of use is a different code usage from the building codes, the discussion is regarding zoning codes. BO Farkas explained the medical marijuana received a conditional use for that specific function. The filter process for conditional use includes parking,

Council member Tollett asked for clarification that all three locations are opening for adult use sales on Tuesday, August 5th. LD Deery confirmed, yes, that is what she has been informed of.

anticipated occupancy load, etc. He further explained that although it may mirror the same

activity, it will have a side effect not considered during the first conditional use.

5. REMARKS AND REPORTS OF CITY OFFICIALS:

Council member Mitchell asked if they open, is it illegal? LD Deery stated they are operating under advice of their legal counsel.

Council member Lipian inquired about infractions with superseding the state law. He further inquired what authority does the state law carry? LD Deery responded her understanding is the home rule authority sides with the city of Elyria, the state law does not supersede the city of Elyria's authority to provide for zoning and other similar laws. She stated she is not of the opinion to have a legal fight in an effort to prove a point, when we are in the process of working on our laws.

Council member Siwierka stated she was in complete agreement with LD Deery. Council member Siwierka suggested that while we are in this waiting period that we inform certain departments of the openings, such as police and fire. She stated that she is not sure if there will be an increase in traffic, however erroring on the side of caution would be best in the long run. She stated she believes many cities are in the same process.

EPD:

Police Captain Grooms provided an update on the arrival of the much-anticipated new Bearcat vehicle from Massachusetts after waiting for two years. The cost of the vehicle was \$260,000. He would like to invite all council members to come look at the vehicle. Captain Grooms stated the vehicle is very impressive. Captain Grooms updated council members of Kyle Smith who is a new auxiliary officer that was recently sworn in. Captain Grooms requested permission for Sargent Wise to attend training for the International Association of Crime Analyst Convention in Las Vegas, that is extended beyond the five-hundred-mile radius.

Council member Tollett moved to approve the travel, Council member Schneider seconded, motion carried.

Council member Oswald asked where the Bearcat vehicle would be stored. Captain Grooms responded they are deciding on a location. Consideration of the old jail sally port is one location with permission of Fire Chief Pronesti or East Broad Street Firehouse, or possibly building a garage.

Council member Tollett inquired about a new marijuana testing that is similar to alcohol testing in that it is saliva based; he wanted to know if the Elyria Police department was familiar with the testing and if they are currently using it. Captain Grooms explained the police department does not currently have that type of testing. He will look into further.

EFD:

Chief Pronesti provided an updated regarding a fire at Ohio Mettalurgical, one of the major industries in town. Although there was some damage to wiring, the business is operating. Chief Pronesti gave accolades to the Sunday fire crew that was on staff for an exceptional job. Fire rescued a little girl that fell in the park as well as a young man that jumped off the bridge. He provided additional accolades to the fire crews that handled all rescues so well. He explained that each rescue is so different from another and carries its own challenges. Three firefighters had to go into the water for the rescue of the young man that jumped the bridge. He expressed his appreciation of the dedication of the firefighters.

Chief Pronesti provided an update on both the young girl, as she was discharged from the hospital and the young man experienced some severe injuries, however he was discharged as well.

Council member Armstrong shared that he witnessed the young man jump off the bridge, he stated he was extremely impressed with the rescue, from the swimmers, LifeCare, Chief Pronesti, and the fire crew. He expressed accolades to everyone involved.

Council member Davis expressed her appreciation and asked that they maintain the safety of Cascade Park as it is a wonderful park. She expressed she wouldn't want people to get the wrong idea that the park isn't safe. The park is beautiful and the accidents are out of the city's control.
