The regular meeting of Elyria City Council was called to order on September 16, 2024 at 6:59 p.m. by President Stewart. President Stewart opened the meeting requesting a moment of reflective silence. The Pledge of Allegiance was led by Council member Siwierka.

# 5. REMARKS AND REPORTS OF CITY OFFICIALS:

Mayor Brubaker: No report

Mayor Brubaker yielded time to McCaulley & Associates to provide grants updates. Exhibit "A" attached

Council member Tollett made a statement that he would like everyone to be aware the idea of a potential new fire station has not been pushed aside with the plans of moving forward with the central maintenance garage. He asked for comment from Mayor Brubaker regarding the topic. Mayor Brubaker shared information regarding a report that was released September 2023 regarding the fire department and one of the key components was the location of a potential fire station in the Southeast quadrant. Mayor Brubaker explained the reporting listed the location of the fire station in the area of Reaser Point Broad Street. In February of 2024, an announcement was made by Mr. Reaser that he would be willing to donate some property to the city of Elyria for the purposes of building a fire station. Mayor Brubaker explained in meetings with Finance Director Pileski, those plans were pulled for a multitude of reasons, one being the dollar amount that was previously considered was around \$27 million, once reviewed by the architects it was reduced from \$24 million to \$1.6 million. He believes the cost will ultimately be under \$21 million. The new fire station was projected to be \$ 3million or under. In addition, the city of Elyria does not own the land and additional work is needed in regards to the project at Reaser Point. Mayor Brubaker stated that at the appropriate time, he would look to get the project bonded and built appropriately.

Council member Siwierka stated the report was good to hear. Her ward is the furthest for any of the fire departments. She expressed concern of the continued growth in the Southeast quadrant and stated that the city cannot continue to serve in all the directions that we're growing without another fire station. Council member Siwierka mentioned specific areas of growth in the areas of Indian Hollow, West Ridge Road, and the new homes in the Southeast Quadrant of the city. She

expressed that it would not be appropriate as a council body to not continue to look at staffing the fire stations and their locations. She expressed that as the city grows, the fire service needs to grow as well.

Minned Ammonia

Council member Oswald inquired about how is cost calculated in regard to the location of the building and the size of the property. Mayor Brubaker explained in the initial meetings with Mr. Reaser, two lots and two parcels are being offered that would be combined in total of a little over two acres. Mayor Brubaker explained the draft designs would suffice.

Council member Lipian stated the development of the fire station sooner than later would be beneficial to the city.

Mayor Brubaker introduced McCaulley and Associates to provide an update on the current status of city grants. McCaulley and Associates are contracted grant writer lobbyist with the City of Elyria. The work they have done has been well received.

President Stewart asked that a copy of the report be provided to the clerk's office. He inquired on the amount that is being pursued on the Middle Ave. sewer project and if \$ 2 million is the confirmed amount? The consultants will confirm the exact number, the request may have been \$3.2 million. Engineer McKillips responded the sewer project would begin at the city of Elyria city limits n Middle Ave. and extend down towards Butternut Ridge Road, with a spur headed towards LaGrange Road.

Council member Siwierka thanked the consultants for their work. She inquired from a hypothetical perspective of what grants would be trending in the future? The consultants believe for local government the need would remain for infrastructure and public safety.

Council member Davis asked if there is an annual cap on the grant amount requested? There is no cap on the number of grant programs, there is a cap per grant.

Council member Tollett expressed his appreciation of the reporting information. He stated it is exactly what was requested. He asked are there any municipal departments that grants are restricted of pursuit. Finding funding for Prosecutor's offices and HR departments tends to be challenging.

Council member Siwierka stated that a few other departments that could use additional funding sources would be the sanitation department in the area of recycling and the cemetery department. Exhibit 'A' attached

The team was able to perform medical techniques and restore a normal heart rate. Expressions of appreciation were made to the following. Lt. Jared Suki, Firefighters Scott Slaughterback, Kurt Higgenbotham, and Cody Burkin. Chief Pronesti provided an update that inspections have been completed on all but fifty buildings. He expressed everyone stressing the importance of the fire station. He also expressed hi appreciation to McCaulley and Associates for their assistance with the fire department successful grants. Chief Pronesti stated the consultants are easy to work with and listen to their needs. Chief Pronesti stated he is committed to staffing a new station.

Council member Tollett inquired on the delivery date of the new pumper truck. Chief Pronesti stated possibly 2026.

Council member Siwierka asked if the completed inspections will transfer to the building department for violations? Chief Pronesti shared that fire inspections include public safety, fire exit signs, extinguishers, hazards. He shared occupancy or change in occupancy are transferred to the building department. Council member Lipian asked what the plans are for the Kipling station. Chief Pronesti explained that would not be his decision to make. Council member Lipian made mention of the wear and tear on Kipling Street with fire vehicles. Chief Pronesti explained that Cedar street was paved, however the back lot on Kipling needs service, however the building is not a functioning building.

Council member Schneider asked where would the response of fire come from to the Bender Rd., Chestnut and Indian Hollow areas? Currently the first to respond is the station at 609 North Abbe. Rd. The first response for the Indian Hollow area is from station engine one.
