1. CALL TO ORDER:

The regular meeting of Elyria City Council was called to order on Monday February 3, 2025 at 7:01 p.m. by President Stewart. President Stewart opened the meeting requesting a moment of reflective silence. The Pledge of Allegiance was led by Council member Cerra. President Stewart requested all cell phones please be turned off or placed on silent mode.

Council member Oswald expressed his appreciation for Council member Lipian's service to the country. Law Director Deery explained the issue of being excused or not is in the city charter and is up to the council members. Elected officials receive salary compensation, so yes, Council member Lipian's salary compensation will continue. Residents of the ward have the liberty of reaching out to city officials or any Council at Large members. Council member Lipian's seat will remain empty until his return. Council member Tollett expressed that Council member Lipian is going to serve in the military, the highest honor that there is, and that he would continue to vote yay on all of his absences. Council member Tollett expressed that as a member of Council at Large he would help with the residents of ward one.

Mayor Brubaker:

Mayor Brubaker shared that over the last week, two long time city employees retired. January 29th Gina Rothgery retired after thirty years most recently from the engineering department. Well wishes were extended to Ms. Rothgery, she was described as an outstanding employee within multiple departments and positions held within the City of Elyria. On February 2nd after thirty years of service in the police department, Lt. Lee Frank retired. Mayor Brubaker shared the

remaining police force stands at eighty-three sworn officers, which includes three in academy and two currently in training. A lateral opportunity will be coming up soon as well as a test later in the year. Mayor Brubaker introduced, Mr. Seth Frabotta, a seventeen year- old senior student at Elyria High School who will be graduating early and has plans to attend Miami University as a Political Science Major. In lieu of completing a final exam, Mr. Frabotta will spend seventy-five hours in city hall over the next few months seeing how government works.

Council member Siwierka inquired if the police chief test was set. Safety Siwierka Director Pyanowski shard that the test is in the process of being scheduled. A few questions will be addressed at the next civil service meeting and the date will be released.

Council member Armstrong inquired if Officer Thacker would replaced retiring Lt. Frank at the FBI facility. Mayor Brubaker confirmed, yes Sergeant Thacker would be the replacement.

Safety Service Director: No report

Finance Director:

Finance Director Pileski shared that January had three paydays as opposed to two. He explained there are two months normally every year where there are three payroll periods. Mr. Pileski shared that January 2025 started off with a three- payroll period month, Elyria Fire Department raises were implemented, as well as twenty-nine police officers and seventeen firefighters that were in the ARPA fund are now in the general fund completely. The cash balance in the general fund dropped \$1,240,483 in January. Expenditures exceeded revenues by \$1,240,483. Mr. Pileski stated that the year did not get off to a good start.

Council member Siwierka inquired of an update on property tax revenue. Mr. Pileski stated the estimate is about \$1.3 extra, the amount is split between the general fund, general bond retirement fund, police pension fund and fire pension funds.

Council member Mitchell inquired if any tax revenue from marijuana sales had been received. Mr. Pileski explained that no revenue is anticipated until June or July and the amount is yet to be determined.

Law Director Deery: No report

Law Director Deery requested that council would adjourn for Executive Session at the end of the agenda for the purpose of discussing collective bargaining agreements, as well as an update on pending litigation.

EPD:

Captain Grooms provided an update regarding promotions that would take place Tuesday February 4th at 3:00p.m. in council chambers. Sergeant Michael Mahoney to Lieutenant and Patrolman Anthony Weber to Sergeant.

Council member Siwierka asked if the FBI would remain in the city of Elyria building space. Captain Grooms confirmed yes, they have expanded a bit.

ASSD Calvert confirmed the developer as Love Retail and explained they are working through logistical issues.

Eng. Schneider:

Engineer Schneider provided a reminder to council member to begin the street selection process so that grading can begin.

Council member Mitchell inquired if ride alongs with Mr. Forthofer would be an option.

Engineer Schneider responded yes, to anyone who would like a ride along.

Council member Schneider inquired about an update to grants for the sidewalks at Hilltop Park area. Engineer Schneider responded no word at currently, however the grant period is not closed.

Council member Siwierka expressed that many of the repairs for her streets were concrete. She inquired if they would be completed this year. Engineer stated yes, they would be completed. Council member Siwierka inquired about an update from the railroad on East Bridge Street. Engineer Schneider stated he has not heard from the railroads, he has heard from a consultant regarding the borings.

Nick Katsaros with First Energy provided an annual update to council members by introducing himself and providing his contact information to everyone. He shared the process of reporting street lights:
